Dear...Joe.

I wanted to write you personally today to discuss the matter of Brittany Griner, because you have handled this issue in such a way that indicates you have no idea whatsoever why your behavior and the behavior of other high-placed and/or professionally-licensed Americans, as well as that of their professional associations, has become a major international embarrassment.

I want to first tell you a little story about my own experiences with American “medicine”. I took up long distance running at age 15. By age 17, the jealousy of the local white trash NiggerNet community toward me, the way I looked, and the way I performed in running my own business, had reached such a fever pitch that I was being given dioxin poisonings while out at restaurants with my parents. This, in turn, led me to seek dermatologic care: as a fair-skinned, light-eyed individual of east European heritage with the ability to grow a full beard, I could not tolerate the poisonings I was being given the way darker-skinned people can without severe symptoms – rosacea and facial folliculitis. But dermatologists were useless and mostly gave me topical drugs that caused other unpleasant symptoms and after some research I simply began taking moderate doses of vitamin A daily because I had no ability to identify how I was being poisoned, when, or why. (This knowledge came later.) I was left with a red face – dioxins will darken your skin, if you have an inherently more melinated skin tone; or redden it, if you do not, much like sun exposure.

An unexpected side effect I discovered was greater stamina when running. Not just that, but quicker muscular and connective tissue recovery, too, in all kinds of exercise – and especially weightlifting. A year later I went off to college and stopped taking it as the NiggerNet people backed off of me a bit and lowered the dioxin levels in my life, rendering it unnecessary. But the effect of vitamin A as a tool of sports medicine was not lost on me, and, years later, while working in a Belgian steel mill at age 34, I began taking it again in order to boost the recovery of the tendons in my hands from the everyday stress of lugging thousands of pounds of steel around all day long. It worked brilliantly – until I ordered a third batch of tablets. This third batch was contaminated with either a dioxin of some sort or perhaps another type of polychloride bisphenol, bringing with it the usual dermatological symptoms and immunocompromisation. But shortly thereafter, your jigger attorney Mark Gitenstein had me fired from the steel mill and so I no longer needed it anyway.

My impression of the Griner situation is this: here you have a very unusual person, a top-level athlete, who has received clearly abysmal sports medicine care in the USA as a result of really ugly racist, sexist, and homophobic behavior by disgusting white trash, men just like you, thanks to a total lack of self-regulatory ability at the American Medical Association. So here she is, abroad, playing for a foreign basketball team in a foreign country, proselytizing the virtues of cannabis for its ability to reduce chronic pain and stress associated with soft and connective tissue injuries in a country where cannabis is illegal. “Here, try my vape, it’s really helped me” is unfortunately the problem here; a matter of reciprocity, really, because the Russians are being constantly hit with bullshit accusations and scandals about various forms of doping that constitute legitimate medical advancements that prevent chronic injuries like Griner’s from even occurring to begin with.

I'm not going to discuss the ethics of doping; it's a discussion for another time that you and your doctors should perhaps do some soul-searching over. Medicine is what is relevant to the understanding of Brittany Griner and her case: she is a victim of discrimination and medical malpractice who needed legal, clean supplements; steroids; and time off. Instead her Ameridocs shoved their thumbs up their own asses and left her a vape machine to finish off her career with.

The problem here now is that you seem to have already lost interest in the entire matter, while not understanding how or why to be embarrassed about it. You don't understand why the Russians are demanding additional concessions and unwilling to make the prisoner exchanges you want them to. You don't want to acknowledge the totally horrific state of American medicine today, nor the horrific state of demand generation for medical services (NiggerNet poisonings, for example) in the USA. All the Russians need to do to throw you away is to speak directly to Americans about what happened to Griner and what is happening to many, many other American patients because of a totally corrupt medical profession who now not only support criminal demand generation for themselves, but for drug farmers and dealers as well. And that last part is why the Russians aren't going to play your stupid little game – because if they do, for even one second, it will turn into a degenerate nightmare that could really do damage to their society.

The decision to imprison Brittany Griner clearly was not taken lightly. Sometimes, heavy-handed methods are required in order to achieve a necessary didactic result. But this all seems to have been lost on you, and lost on the entire Department of State, and lost on the entire American medical community. So here I am, explaining it to you. As it happens, I also talk a lot about the unavoidable downward trajectory of America over the next 20 years in connection with the inverted labor market that incompetent white trash narcissists like yourself have put in place: I think you're fucked, and I'm very happy to have renounced my US citizenship in February (still waiting on my Certificate of Loss of Nationality, by the way – see if you can pull your thumb out of your ass and get that to me, because I've already paid for it and it's now four months late.)

What you need to consider, now that I've explained it to you, is the following: you need to prepare a larger and more attractive prisoner exchange for the Russians. In addition to Viktor Bout, you should prepare additional offers as part of the deal for Griner. Aleksandr Uss and Roman Seleznev, both sons of Russian senators involved in activities that the FBI arbitrarily tolerated for years, would be admirable additions to the deal. Paul Whelan, however, should be considered separately: he's a criminal, not a victim who inadvertently broke the law. I'm aware that American prosecutions are arbitrary, but Russian prosecutions are often not. Just another consideration as you pull the legal and diplomatic wool off from over your eyes here, so to speak.
